



General Liability Waiver and Release

By signing this Release (this “Release”), I, on behalf of myself and/or on behalf of my child or children, as applicable (together, the “Releasers), hereby acknowledge and agree as follows:

1. Releasers understand that signing this release is a condition to Releasers’ membership in the Citizen Science Lab, participation in any of its programming, and access to and use of the Citizen Science Lab facilities and equipment, including access to and from the public streets to the Lab and to and from the lobby and other common areas of the Energy Innovation Center (the “Facilities”).
2. Releasers understand that Urban Innovation21 and its affiliates, along with their officers, directors, employees, agents, volunteers, contractors, and subcontractors (collectively, including each of their respective affiliates,, the “Releasees”) shall have no duty whatsoever with respect to Releasers’ membership in the Citizen Science Lab, participation in any of its programming or access to and use of the Facilities (collectively, Releasers’ “Participation”).
3. As consideration of our Participation, Releasers hereby acknowledge and agree that Releasers shall be liable for any and all liabilities, losses, damages, injuries, costs and expenses of any kind whatsoever, be they to person or property, arising in connection with Releasers’ Participation.
4. As further consideration for Releasers’ Participation, Releasers hereby release and forever disclaim all claims or causes of action of any kind whatsoever (including, without limitation, claims or causes of action for loss, damage, or injury) that may be directed against the Releasees, and each of them, occurring within or about the Facilities or otherwise arising from Releasers’ Participation.
5. As further consideration for Releasers’ Participation, Releasers shall indemnify, defend and hold harmless the Releasees, their successors and assigns and their officers, directors, employees, agents and owners (each a “Releasee Indemnified Party”) from and against any and all liabilities, losses, damages, injuries, costs and expenses of any kind whatsoever, be they to person or property, incurred by a Releasee Indemnified Party by reason of or arising out of such Participation.
6. Releasers understand the terms of this Release and knowingly and voluntarily acknowledge and agree to each of the terms and conditions hereof.
